We are currently in a phase of working out a survey design for web-based questionnaires that should allow us to run a discrete choice experiment aiming at the assessment of peoples' preferences towards the protection of the two above-mentioned areas. Samples in PL and BY will value increases of the national park (strictly preserved) areas of Białowieża/Biełavieskaja Pušča, and samples in SE and NO should face similar scenarios for Fulufjället/Fulufjellet. We have previously presented a choice experiment applied within a pilot survey for PL/BY in the summer of 2012. We will of course have to adapt and develop further this draft design for an application in Fulufjället/Fulufjellet. That is, we must clarify the viability of extending zones with strict nature preservation ("undisturbed zones"), or if national park borders as such can be extended, or if there is a scope for corridors towards nearby preserved nature areas. We are aware of the potential conflict between protection/preservation and traditional use (forestry, hunting, fishing, etc.) as well as the tourism activity around Fulufjället/Fulufjellet, on both sides of the border.

A very rudimentary draft of the pilot questionnaire from Białowieża/Biełavieskaja Pušča adapted more or less directly to Fulufjället/Fulufjellet is attached.
